The regular meeting of the Marshall District Library Board was called to order by President George Guerin at 7:00pm. Roll call was read by Secretary Martha Frohm. She also mentioned that programs have been well attended. The Library was closed for two days due to extremely cold weather. Directoe Semefero passed out MDL Annual Reports which were nicely done and well received.

## Committee Reports:

## New Business:

Budget amendments. The suggestions were listed in our Board packets. They are State Aid-a decrease of \$500, interest on CD's an increase of \$500, overtime pay-an increase of \$2000. and Retirement-a decrease of \$2000. Martha Frohm made a motion to accept the changes; supported by Kathie Maitland. All present voted yes.

## **Board Officer Nominations:**

George Guerin and Martha Frohm can no longer serve as President and Secretary respectively. Kathie Maitland has assumed the duties of Treasurer and would like to continue in that capacity.
